Consequent upon the approval of Chief Minister Sindh the following enhancement in compensation to the Officers / Officials of Sindh Police with effect from 01-06-2009, irrespective of grades killed / incapacitated in encounters including bomb blasts, riots, watch and ward duties or terrorist activities but no including road accidents are notified herewith:-

S.NO.	Description	Existing compensation	Enhanced rates
1.	Compensation to the families of <b>Shaheed</b> Officers / Officials irrespective of grades	Rs.500,000/-	Rs.2,000,000/- and one Plot.
2.	Permanent incapacitation.	Rs.300,000/-	Rs.500,000/-
3.	Temporary incapacitation	Rs.50,000/- to Rs.150,000/-	Rs. 50,000/- to Rs. 200,000/- depending upon the gravity of injury
