TERMS & CONDITIONS:

- Contractors /Contracting Firms should be registered with Pakistan Engineering council (PEC), in Category at least C-5 or above. FBR income Tax, Sales Tax & (Sindh Revenue board where applicable) Valid NTN and STN registration certificates will be required for the financial year 2016-17. A certificate mentioning that, "the Firm is not involved in any criminal case" will be required.
- Contractors/Contracting Firms are advised to quote rates on Unit/Job/Per SFT / RFT. Basis.
- Payments shall be made for the working days of Jobs unit basis as the case may be on completion of each item/work, on the basis of measurement and verification in accordance with specification.
- 4. The Work calculation/RCE may vary by (+) or (-) 5%.
- The contractor/ Contracting firms will be required to show evidence of experience/ capability in respect of personnel/machinery, financial position etc. (profile of the firm).
- 6. Contractors/Contracting Firms black listed by Government Departments or agency will not be allowed to participate in the tender/bid (participating contractors/contracting Firms will be required to submit affidavit to the effect that they are not black listed) from any Government, Semi Government and Private organization.
- Contractor will be required to provide Copy of CNIC and Certificate of PEC Registration (Category Wise).
- Only Bid offered on the prescribed tender form issued by this department shall be accepted, however.
- The contractor/firm may submit offer for one or all or as many locations.

- 10. Conditional tender / application will not be entertained.
- 11. Validity of Bid/offer shall be at least 60 days from the date of opening of tender.
- 12. Work must be completed with in 90 days.
- 13. The competent authority reserves the right to reject all or any tender/bid subject to and in accordance with the relevant provisions of the Sindh Public Procurement Rules 2010 and amended -2013.

- 15. Tender/ Bids (duly Sealed along-with call deposit) shall be dropped in the tender box (placed in the office of the Addl: Inspector General of Police, Karachi Range at KPO Karachi Conference room at 4th floor) on 13.12.2016 at 1300 hours sharp.
- 16. The proposed bids will be opened after verification of required documents by the Procurement Committee on the same day i.e. 13.12.2016 at 1500 hours, in presence of duly authorized representative (who may like to be present) of contractor/contracting Firms participating in the tender/Bid.
