Applications are invited from Ex-Army Personnel (Combatant) for the post of constables (BPS-05) in Special Protection Unit, Sindh Police on the basis of 02 years contract.

Applications are invited for the post of Police constables (BPS-05) on the basis of 02 years contract in Special Protection Unit (Sindh Police) from Ex- Army Personnel (Combatants only) bearing the domicile of Sindh Province (Rural+Urban). Applicants must fulfill the following eligibility criteria.

AGE:-

46 Years (maximum) for soldiers
48 Years (maximum) for Non- Commissioned Officer
Till last date of advertisement i.e 31.01.2017.

QUALIFICATION:-

Matriculation (Minimum) Or AEC-1st.

PHYSICAL STANDARDS

i) Candidates must be in good physical health and should fulfill the following conditions who are combatants and not dismissed from Armed Force of Pakistan and possess clear service record.

Height 5'x2" (minimum)
Chest 33x34½ (minimum)

Eligibility

Following Units of Pakistan Army are included in combatant:-

- a) Armour, Artillery, Engineers, Signals & Air Defense.
- b) Infantry.
- c) Aviation, EME, Army Service Corps, Ordnance & Gen Duty soldiers of Army Medical Corps.

APPLYING/RECRUITING PROCEDURE.

- ii) All Candidates, who fulfill the said conditions, may submit applications in the office of the DIGP/Commandant RRF/SPU Sindh Karachi through courier service or in person by hand or all relevant District Superintendents of Police offices.
- iii) Applications should be accompanied by the following documents.
 - 1. Attested copy of service certificate/Discharged Book of last department.
 - 2. Attested copy of educational Certificate.
 - 3. Attested copy of Higher Qualifications (if any).
 - 4. Attested copy of Characters Certificate.
 - 5. Attested copy of Domicile Certificate.
 - 6. Attested copy of P.R.C.
 - 7. Six (06) Recent Passport size photographs.
 - 8. Attested copy of CNIC.
- iv) All documents listed in Para (iii) above, except photographs, shall also be produced in original at the time of preliminary scrutiny and interview.
- v) Candidates who have applied earlier should submit fresh application as explained above.

- vi) LAST DATE FOR THE RECEIPT OF APPLICATIONS 31.01.2017 AFTER WHICH NO APPLICATION SHALL BE ENTERTAINED.
- vii) SCRUTINY & PHYSICAL TEST:-
- 1. All candidates fulfilling the above conditions will appear for the physical examination.
- 2. Such candidates, who are found eligible/ qualified, after the scrutiny of documents and physical examination/ test, shall appear in interview.
- Time and place for physical/written test shall be announced later on through press/Media & SMS service.
- 4. A thorough medical examination of candidates on the prescribed form/Proforma shall be conducted, who are selected for appointment.

Note:-

- i) No relaxation in age, education or physical standards will be allowed to the candidates.
- ii) No TA/DA shall be admissible for appearing in any test/interview or for joining duty, if selected.
- iii) There is no fee for application form.
