TERMS AND CONDITIONS

- i. The appointment order shall be purely on temporary basis and to be confirmed on completion of successful probationer period of two (2) years.
- ii. They will undergo training course in I.T Sindh Police, Karachi
- iii. If their character/antecedents verification reports are found satisfactory by District Police and Special Branch.
- iv. If all of their documents / educational testimonials are found genuine after verification from the issuance authority through proper channel. If any of their documents are found forged/ fake at any stage, their services will be terminated and they shall be proceeded against legally.
- v. In case they resign from the post without giving two months notice in advance, they will have to deposit salary of two (02) months in the Government Treasury.
- vi. They will be governed by the Sindh Civil Servant Act 1973 and Rules / Policies framed there-under from time to time.
- vii. Their service can be utilized throughout Sindh Province.
- viii. They shall not be entitled to change of cadre from I.T to any other cadre.
- ix. They will not be entitled to claim any TA/DA for joining duty.
- x. The Seniority will be counted from the date of this appointment order and order of merit under Sindh Civil Servant rule (Probation, Confirmation & seniority) rule 1975.
- xi. They will join their duty to the office of DIGP IT Sindh within 15 days of issuance of this appointment order.
