## ORDER

Consequent upon recommendations of Sindh Police Recruitment Board bearing No.8535-50/EB-III/T-7/S&S, dated 04.08.2021, duly approved by the Inspector General of Police Sindh, the mentioned below Candidates, who have been declared medically fit by the Medical Superintendent Police Hospital and after verification of Character / antecedent from Local Police as well as Special Branch, Sindh, are hereby appointed as Police Constable (BS-05) in Sindh Police against the existing vacancies of Sindh Reserve Police (SRP), with immediate effect:-

- O2. They will draw pay from SRP against existing vacancies. However, their seniority shall be maintained in respective district of Domicile as per Police Rules, 1934.
- 03. Their appointment is subject to the following conditions/codal formalities:
  - i. Verification of having good character/antecedent from CRO (I.T. Branch CPO).
  - ii. The appointment shall be purely on temporary basis and to be confirmed on completion of successful probation period of three years.
  - iii. The appointment shall be governed under Repeal of Police Act, 1861 and revival of Police Order, 2002 (Amendment) Act 2019 and existing Law as well as Police Rules, all other relevant laws, Rules framed as such.
  - iv. They will undergo Recruit Training Course as provided under Chapters 12 & 19 of Police Rule 1934 and other special training programmes devised by the Training Branch CPO from time to time.
  - v. In case of resignation from the post/service without giving two months notice in advance they will have to deposit two months salary in the Government exchequer.
  - vi. They will have to join the office of the DIGP SRP at Qayyumabad Karachi for further duty within 15 days of issuance of the appointment order. In case of non-reporting within the given time frame, this order shall stand cancelled.

- vii. They will not be entitled to claim any TA / DA for the above purpose and joining duty.
- viii. Being a member of Police force they will have to serve any part of the province of Sindh as per orders of the superiors.
- ix. The appointment shall be liable to be cancelled in case of any above condition is not fulfilled or any document is found fake/forged at any stage.
