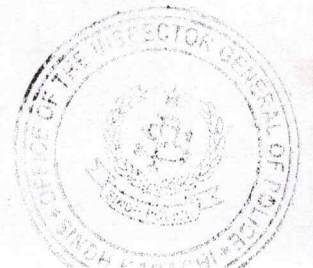
Subject: **FINAL SENIORITY LIST OF JUNIOR CLERKS (BPS-11) OF SINDH POLICE.

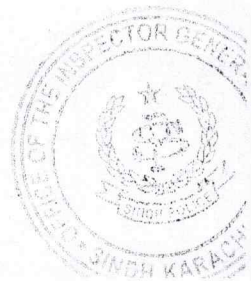

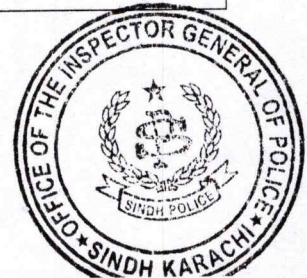


