SUBJECT:- FINAL SENIORITY LIST OF ASI's OF KARACHI RANGE AS ON 12-03-2020.

Please refer to this office letter No. EB/C&P/ASI/TSL/- 48063-93 dated 20-12-2019, on the subject cited above.

A committee was constituted vide this office order No. EB/C&P/SI/- 22542-46 dated 19-02-2020, to examine the objections / claims against the tentative seniority list of ASIs of Karachi Range. The committee unanimously agreed on the following line of action.

- i) As matter of policy the date of actual promotion in the rank of ASI Shall be considered as date of appointment by promotion (those who were promoted from the rank of HC to ASI) and shall be confirmed after completion of 02 years probationary period of promotion as required under police Rule 13.18.
- ii) According to police Rule 12.2(3) seniority of upper subordinates will be reckoned from the date of initial appointment as ASI, which means the date of either promotion as ASI from HC or direct appointment as ASI. Such date is the benchmark for the determining seniority of upper subordinates. This date will not be changed and no appeal in this regards shall be entertained.
- iii) Directly appointed prob. ASI shall be confirmed in the rank of ASI after completion of 03 years probationary period as required under P.R 12.8.
- iv) Seniority list of ASIs shall finally be settled by dates of confirmation in the rank of ASI under P.R 12. (3).



- v) Selection of lower subordinates on promotional course (s) shall be made strictly in accordance with their seniority. However an official can be considered for nomination on such course (s) before his turn, if there is an apprehension that he will become overage for that course on his turn. In that case, his / her name shall not be brought on promotional list until his immediate senior is considered for the same.
- vi) A Head constable being considered for promotion by the DPC and is deferred for non production of service record, or any other reason beyond his control, he shall not be disadvantaged if DPC defers him. And subsequently when the deferred officers are dully promoted to the rank of ASI, he shall retain his inter-se-seniority along with batch mates without granting them promotion from date in retrospect.
- vii) The HCs superseded or ignored by the Department Promotion Committee (DPC) on grounds of major penalty shall lose their seniority, unless the same has been set-aside by the appellate authority within time period specified under the rules:
- viii) No ante-dated seniority shall be granted in the rank of ASI on the basis of initial date of appointment as Constable or late qualifying departmental promotional course (s) in the past.
- ix) If any listed ASI is enjoying ante-dated seniority in the rank of ASI, which is in contradiction with the policy guideline issued by CPO Sindh and surface later, then his case will be reviewed by the committee and decision regarding his seniority will be taken according to existing rule / policy.

After making necessary modification / correction, the final seniority list of ASIs prepared on the basis of date of actual promotion / appointment in the rank of ASI and finally settled by date of confirmation in the rank of ASI under police Rule 12.2(3), 12.8, 13.18 as well as, CPO Sindh Policy guidelines, is enclosed for circulation of the same to all concerned.
