All promoted Police officers of Karachi Range shall be transferred to Investigation Branch for a period of 02 years. No Police Officer shall be transferred from Investigation Branch before completing his mandatory two years. In case of transfer from Investigation on account of any exigency, the transferred officer shall be reverted to his substantive rank of ASI and he shall lose his promotion of officiating Sub Inspector. In no way transfer from Investigation Branch before mandatory two years and continuation of promotion as officiating Sub Inspector shall go together and his promotion shall be considered withdrawn as soon as he is transferred prematurely.

Adverse record of any individual if not reported earlier by the Zone / Unit and surfaced after the recommendation of Departmental Promotion Committee from any corner shall be taken for due consideration. After proper verification of adverse record, the promotion order of the incumbent will be turned down at once by the Competent Authority and departmental action will also be taken against the concerned officials, accordingly.

All newly promoted Sub Inspectors will be on probation for a period of 02 years as per provision P.R 13.18 of Police Rule 1934.
