

ORDER

ASI Rizwan Zaidi of BDU Special Branch Hyderabad (now closed to CPO) was awarded major punishment of Removal from Service by SP/SRP Hyderabad vide order No. 7501-06 dated 04.05.2016, on the charge of his involvement in corrupt practices and managing false and fabricated record for process of recruitment held in SRP Unit Hyderabad in the year 2012 to 2015.

He did not submit appeal to the next appellate authority within the specified period of 30 days and instead file Service appeal before the Sindh Service Tribunal Karachi. The Honourable Service Tribunal in appeal No.1454/2016 has passed the orders to set-aside the original orders dated 04-05-2016 passed by the SSP SRP Hyderabad. Consequently the Home Secretary Sindh has issued orders of his re-instatement in service vide order No. POL-I-HD /12-05/2016 dated 17.03.2017 subject to conduct Denovo proceeding in the matter.

In compliance of orders of Home Secretary Sindh Karachi, Addl. IGP/Special Branch Sindh was nominated as Enquiry Officer to conduct denovo proceeding vide this office order 2484-91/E.II/DP dated 21.04.2017, who submitted the enquiry report conducted by SSP (Technical) Special Branch, Karachi vide No.121 dated 20.02.2018, wherein he has proved the charges against delinquent officer. The Enquiry officer further concluded that the perusal of entries of station diary revealed that he had passed the direction on behalf of the then SP/SRP Ghulam Nabi Kerio. He was also pressurized/harassed the staff unnecessarily in order to achieve his ulterior motive, i.e illegal recruitment. The Enquiry officer has recommended that the delinquent officer may be awarded major punishment of Dismissal from Service.

He was issued Show Cause Notice vide No.8332/E.II/DP dated 28.06.2018. He submitted reply to the Show Cause Notice and denied the allegations leveled against him. He was called and heard in person. His reply to the Show Cause Notice was considered at length and found not satisfactory.


In the light of denovo proceedings/findings of Enquiry Officer he is awarded major punishment of Dismissal from Service with immediate effect.
