Senior Clerk Tariq Ali Khaskheli of I.T Branch CPO Sindh, Karachi was issued Show Cause Notice vide No. 5218-19/E-IV, dated 01.04.2016 & Final Show Cause Notice vide No. 15732-33/ E-IV, dated 20.08.2016, on following allegations:-

"As per enquiry report held in pursuance of orders of the Honorable Supreme Court of Pakistan passed in HRC No. 16082-S dated 23-12-2015, you have found for preparing the documents and thus facilitated the wrong doing knowingly and willingly regarding illegal recruitment process."

The respondent official has submitted his reply to the Show Cause Notice as well as Final Show Cause Notice and also heard him in person on 12.11.2019. His arguments were listened in detail. He had written note sheet on the directions of the then IGP Sindh Mr. Ghulam Haider Jamali, PSP. As such major responsibility lies on his controlling officer but he cannot be acquitted from his responsibility altogether. He is therefore, **awarded major punishment of reduction of one year to lower stage in time scale** as specified under rule 4(b)(i) of Sindh Civil Servants (Efficiency & Discipliner) Rules, 1973.

02 - He submitted reply to the SCN, which was perused by the DIGP/SRP Sindh Karachi and afforded opportunity of personal hearing on 31-12-2018. His written as well as verbal explanation was not satisfactory. Therefore, issued final SCN vide bearing No. SRP-ADMN/DP/504/2019 dated: 11-01-2019.

03 - He submitted his reply to the FSCN, which was not satisfactory. Therefore, awarded major punishment of dismissal from service by the DIGP/Commandant SRP Sindh Karachi vide order bearing No. SRP ADMN-4866-68/19 dated: 16-04-2019.

04 - He preferred an appeal to CPO to re-instatement in service, called in OR on 21-09-2019 & heard in
