Inspector Mumtaz Ali Magsi (u/s) of Karachi Range presently closed to CPO Sindh was issued /served Show Cause Notice vide No. 16531-32/E-II/DP dated 06.11.2019, under Rule-6 (3) (b) (i) of Sindh Police (E&D) Rules 1988, on the following allegations:-

"An enquiry conducted by the Commandant SBB,EPTC, Razzakabad, Karachi on the complaint of Shahryar Rafiq son of deceased Rafiq Ahmed Awan on the allegation that his father gave him 50 lac rupees to be invested in any business venture. He invested that money and stated paying them one lac rupees monthly and that payment continued for three months. Afterwards he stated dilly dallying techniques and refused to pay the remaining amount. A call recording of complainant with him in his possession in which he accepted that yes he owes money and he will return the money very soon. According to his statement he said that the matter is in Court and it will be settled in the Court of Law and he maintained that he returned 50 lac rupees Mr. Shahryar Rafiq son of the deceased Rafiq Awan. However, he returned only 5 lac rupees to him.

The enquiry officer failed to understand how come a young son of deceased Police Officer demanded from a serving Inspector of 50 lac rupees if the said amount had already been paid by him the explanations put forwarded and found to be contradictory and un-plausible and a FIR of cheating was also lodged against him on 06.09.2019. As per opinion of the E.O, he is basically a cheater and not fit to serve in Sindh Police Department. He is trying to usurp the money of his old deceased friend. His act constituted a gross misconduct being a member of disciplined force.




