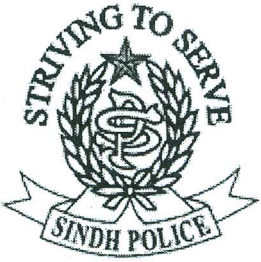



2/- List "F" is maintained under Police Rule 13.15, while promotions from the rank of Sub-Inspector to the rank of Inspector are made under Police Rule 13.16.

3/- As per report of AIGP Forensic Division Sindh 03 vacancies in the rank of Inspector are available. Therefore, the Committee considered such cases against 03 clear vacancies of Inspectors of Forensic Division.

4/- The following criteria were fixed by the Committee:-

- i. An officer must have 08 years service as upper-subordinate, out of which 05 years as S.I as per Rule 13.14 (2) of Police Rules 1934.
- ii. Those who have major punishment during last three years and those who have at least 03 major punishments in their entire service shall be deferred.
- iii. Those who have 5 minor punishments since last promotion as Sub-Inspector shall be deferred.
- iv. Police officers on deputation to Federal Government Departments / Agencies, or Extra Ordinary Leave shall be deferred till their return to Sindh Police.
- v. Police officers facing DP/SCN/involved in any criminal case or ACE enquiry /case shall be deferred till finalization of the case(s).

- vi. According to Rule 12.3-B (2) of Police Rules 1934, candidates thus enlisted in technical district shall be deputed to the Police Training School to under go the full course prescribed for directly appointed Asistant Sub-Inspectors. However, there is no provision in Police Rule about Upper School Course for Sub-Inspectors of technical district /cadre. Moreover, West Pakistan Non-Gazetted Technical Staff of Finger Print Bureau Service Rules, 1969 also does not mention Upper School Course for S.Is of Forensic Division for admission their names to list "F" and promotion to the rank of Inspector.

5/- The following Sub-Inspectors of Forensic Division of Sindh Police being cleared in all respect are admitted to list "F" and promoted to the rank of Inspector with immediate effect:



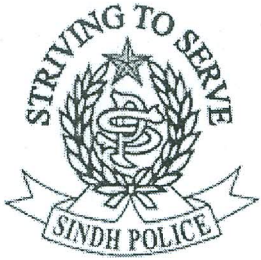
