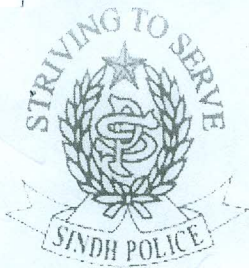



"You were awarded Major Punishment of Forfeiture of Approved Service for One Year by DIGP Hyderabad Range under his order No. 3423-25 dated 10.05.2017, on the allegations that Mr. Farooq Amjad, ASP/SDPO Thatta conducted an enquiry on the complaint of PC/1014 Farhan Khan S/o. Bundo Khan of District Jamshoro, who alleged that you have falsely implicated his brother namely Rehan Gaddi in various cases and injured him in fake encounter and prove allegations that you with the help of other Police Officials have transgressed the authority and abused your official powers.

On your above part of misconduct the E.O/ASP recommends for award of Major Punishment of Dismissal from Service, but DIGP/Hyderabad had taken lenient view and you were awarded Major Punishment of Forfeiture of Approved Service for One Year meanwhile another complaint received from Complainant Bundo Khan S/o. Shehzad Khan, on the same allegations.


The authority is un-satisfied with the decisions taken by DIGP/Hyderabad vide his order No. 3423-25 dated 10.05.2017, hence you are liable for enhancing the Major Punishment of Forfeiture of Approved Service into Major Punishment of Dismissal from Service."

2/- The Competent authority after perusal of reply of above named Inspector has ordered that the punishment has already been awarded by DIGP/Hyderabad Range on the same allegations. Hence, above SCN is hereby filed.
