2/- The Committee unanimously fixed the following criteria to ascertain the suitability of senior most and confirmed Sub-Inspectors of BDU Cadre for inclusion of their names in List-F and their subsequent promotion to the rank of Inspector:-

- i. The officer must have 08 years of service as upper-subordinate, out of which 05 years as SI as per Rule 13.14 (2) of Police Rule-1934.
- ii. Police Officer being considered eligible should have no major punishment during last 03 years.

- iii. Police Officer being considered eligible should have no 10 minor punishments during last 03 years.
- iv. Police officer on deputation to other departments i.e FIA, ACE, NH&MP & NAB etc shall be considered till their return to Sindh Police.
- v. Police officer facing Departmental Proceedings / SCN / involved in any criminal case or AEC enquiry / case shall be deferred till finalization of the cases.
- vi. The officers must have complete ACRs/record for the last 5 years duly counter signed without any adverse remarks.
- vii. Officer having two or more ACRs of "B" class will be a disqualification.
- viii. Seniority maintained as per Judgment of Honorable Supreme Court of Pakistan C.P No. 493 & others of 2015.
