

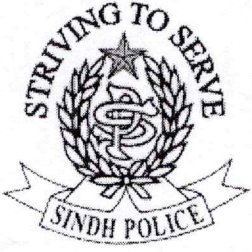

1. An enquiry was conducted by Addl:IGP Special Branch Sindh, Karachi vide No. 1118 dated 19.5.2017, regarding investigation of case FIR No. 13/17 u/s 302/324/ 114/506-B/147/148/149 PPC of PS Naonabad District Sanghar.
2. SI Ghulam Nabi Taheem, former SHO Naonabad was reverted/placed under suspension and closed to CPO vide this office order No. 3457-61/E.II/DP dated 19.5.2017.
3. He was issued SCN vide this office No. 3771/E.II/DP dated 1.6.2017, who submitted reply to the SCN.
4. He was posted to Mirpurkhas Range and enquiry/ SCN and reply to SCN were sent to DIGP/SBA Range with the direction to decide his SCN vide this office order No. 5136-44/E.II/DP dated 3.9.2017.
5. SCN decided to DIGP/SBA by awarding him major punishment of forfeiture of approved service for one year vide order No. 10920-25 dated 9.10.2017
6. Direction issued to DIGP/SBA to review his above punishment and he may be awarded any of the listed punishment under RSO-2000 vide this office letter No. 9902/E.II/DP dated 26.10.17.

1. Deferred for admission to list "F" and promotion to the rank of Inspector in the DPC held in the year 2016 due to major punishment of "Reduction of Pay by Two Stages" vide this office order No. 9295-99/ E-II/DP dated 26.12.2016.
2. He filed Service Appeal No. 419 of 2017 in Hon'able Sindh Service Tribunal, against major punishment of "Reduction of Pay by Two Stages".
3. The Hon'able Sindh Service Tribunal vide his judgment dated 13.09.2017, set-aside the above said major punishment and also directed to proceed denovo proceedings against above named officer.
4. Syed Muhammad Ali Raza, PSP, SP RRF Naval Base, Karachi was nominated as an Enquiry Officer to conduct denovo proceeding against above named officer vide this office order No. 9090-98/E-II/DP dated 05.10.2017.
5. The said Enquiry Officer submitted his enquiry report vide his letter No. SP/RRF-I/RDR/NB/9440 dated 19.12.2017 that no solid evidence was found against above named officer and also recommended that enquiry against him may be set-aside / file to ensure justice.
6. By agreeing with the recommendation of Enquiry Officer such enquiry was filed against above named officer vide this office order No. 629-35/E-II/DP dated 11.01.2018.
7. He was admitted to list "F" and promoted to the rank of Inspector w.e.f. 22.02.2018 in the DPC held in the year 2018.
8. He submitted an appeal received through DIGP / Larkana Range letter No. E-I/12998-99 dated 11.05.2018, for assignment of original seniority alongwith his batchmates in the rank of Inspector w.e.f. 01.12.2016 instead of 22.02.2018.

ORDER.

Inspector (L-489) Jabir Hussain Lahori of Larkana Range has preferred an appeal against order No. 9295-99/E-II/DP dated 26.12.2016 to fix his seniority as Inspector alongwith his batchmates.

2/- He was deferred admission to list "F" as he was awarded major punishment in 2016 vide this office order No. 9295-99/E-II/DP dated 26.12.2016. This punishment was later on set aside by Sindh Service Tribunal vide Judgment dated 13-09-2017 passed in Service appeal No. 419 of 2017. The Denovo enquiry on this Judgment was conducted by Syed Muhammad Ali Raza PSP, SP/RRF Naval Base Karachi who concluded that no solid evidence was found against officer and he recommended to file enquiry.

- 3/- Addl: IGP/Sindh agreeing with the recommendation of F.O filed that enquiry.
- 4/- He was later admitted to list "F" and promoted to the rank of Inspector in the DPC held on 22.02. 2018.
- 5/- From above discussion the contention of Inspector Jabir Hussain Lahori for giving him seniority alongwith his batchmates as it stood in the DPC held on 01-12-2016, on the grounds that the reason for which he was deferred, has been proved to be un-founded and his major punishment has been set aside, stands genuine. Therefore his appeal is accepted and he is given seniority alongwith his batchmates as stood in the DPC held on 01.12.2016 instead of 22.02.2018 and he is admitted to list "F" and promoted as Inspector w.e.f. 01.12.2016.

I have heard the applicant in person and gone through the case in detail.


2. Lastly enquiry into the matter was entrusted to DIGP/Training Sindh, Karachi vide this office order No. 8362-68/E-II/Insp, dated 28-06-2018, who submitted his findings vide letter No. 15541 dated 03-08-2018.
3. Some of the findings of the aforesaid enquiry are below: -
 - i. In view of statements of the complainant and others witnesses no proof of illegal gratification / bribe taken by the Inspector Ishtiaque Ghori from the complainant for releasing the subject Vitz Car bearing No:AWK-393 was proved.
 - ii. SIP Sharjeel Mangi brought the aforesaid Car with the complainant to ACLC Sharifabad Karachi and made an entry bearing No. 07 in the Roznamcha to this effect. However, the entry regarding Laptop and Credit Card was not made.
 - iii. The enquiry officer also noticed that Inspector Ishtiaque Ghori has arrested many criminals and recovered snatched articles during the discharge of his official duties on various occasions.

4. In the light of the above findings charges against Inspector Ishtiaque Ghori are not proved. The Enquiry Officer has recommended that enquiry may be filed and he may be re-instated in service.
5. On the basis of enquiry report, his major punishment of dismissal from service awarded to him by Addl: IGP Karachi vide order No. EB/E-II/PI.01-07/ 138899-900 dated 11.12.2017 is set-aside. He is re-instated in service.
6. His out of service period is treated as such.
