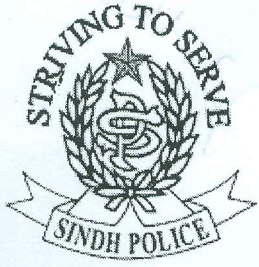

ORDER

Sub Inspector Sohail Akhtar Sulheri has submitted a review appeal to this office against the rejection of his earlier appeal vide order No.8527-31/ E-II/DP dated 03.07.2018. His appeal was heard by this office under Rule 16.32 of Police Rules 1934.

The brief facts of the case are as follows:-

- i) The appellant was issued a Show Cause Notice by Addl: IGP/Karachi on 14.07.2017 on the following charges.
"It has been noticed that PC Imran Haider presently posted in Security-I, Karachi was your front man/beater and he picked up innocent persons from the area of your responsibility and kept them under illegal detention in your Police Station and later released after getting huge amount of money as bribe. The whole criminal act of above named PC was set-up on your direct command and control. A case FIR No.145/2017 u/s 384/385/342 PPC of PS Birgade against above named PC has also been lodged. Such act on your part shows that you are running a Mafia Nexus under the umbrella/cover of Police Uniform which causes serious disgrace for the whole police department in the eyes of General Public and also shows that you are a corrupt and immoral Police Officer and liable to be dealt department"
- ii) He has submitted his reply to the Show Cause Notice, on which a Final Show Cause Notice was issued on 30.10.2017 and subsequently he was awarded with major punishment of "Reduction of rank from Inspector to Sub-Inspector" vide order dated 26.12.2017.
- iii) He preferred an appeal to this office and the then IGP/Sindh entrusted an enquiry to Mr. Omer Shahid, PSP the then SSP West who have exonerated the officer from the charges mentioned in the Show Cause Notice.
- iv) On such enquiry report, the then IGP Sindh vide order No.3200-7/E.II/Insp dated 12.03.2018, set-aside the award of major punishment and restored his substantive rank of Inspector.
- v) The Officer was issued another Show Cause Notice on 20.11.2017 on the following charges:-
"Reportedly, you are supporting street criminals and also involved in collection of extortion (bhatta) from fruit carts, hafta bazaar, taj complex, but stand, lines area and kabbari market. You approximately collect Rs. 4-5 Lacs per month in the jurisdiction of Brigade PS, through your beater namely HC Imran Hyder of Security-I, Karachi and private beater namely Azam Butt. Such act on your part is a gross misconduct and liable you to be dealt with departmentally"

- vi) He has submitted his reply to the Show Cause Notice and enquiry was entrusted by Addl: IGP/Karachi to the then SP Saddar Tauqeer Muhammad Naeem, PSP who has submitted his report on 29.05.2018 and recommended that strict punishment should be awarded to Inspector Sohail Akhtar Sulehri (appellant). He was awarded major punishment of "Reduction of rank from Inspector to Sub Inspector" vide order dated 04.06.2018.
- vii) He preferred an appeal to this office which was rejected vide order No. mentioned above (appeal against which).

3. From the perusal of available record and the personal hearing of the officer, following facts came to forth:-

i. The allegations mentioned in both Show Cause Notices are almost identical whereby he was charged of collecting illegal money (extortion) from the innocent people while posted as SHO Brigade through Head Constable Imran Haider of Security-I Karachi. It is a settled principle of law that a person cannot be punished for the same offence twice. Hence, the award of punishment on similar charges seems unjustified.

ii. The officer was re-instated by the office of IGP Sindh after the matter was enquired by a senior officer of the rank of SSP and on re-instatement, he was again punished on the basis of enquiry conducted on almost identical charges by a junior officer.

iii. The charges mentioned in the Show Cause Notice are otherwise vague in nature as no specific complaint was mentioned by any person from whom the officer have collected illegal money. Instead the officer has presented the statement submitted by the businessmen of the area who stated that they have never seen any Head Constable namely Imran Haider never paid any amount to him.

4. He has preferred the instant appeal on 10.07.2018 which is well in time, hence, his appeal is considered and the major punishment awarded to him by Addl: IGP Karachi vide order No.66466-75 dated 04.06.2018 and order No.8527-31/E-II/DP dated 03.07.2018 are hereby set-aside. His original rank of Inspector is hereby restored.

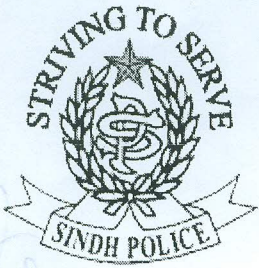

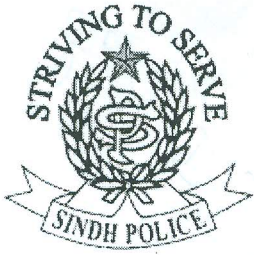

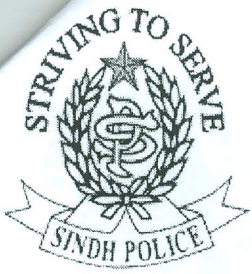
