NOTIFICATION

In exercise of the powers conferred by rule-7 (ii) of Sindh Police Benevolent / Welfare Fund (SPBWF) Rules-2017 and in pursuance of the decisions taken by the SPBWF Board, in its 19th meeting, held on 08.11.2021, further decentralization of selected Welfare Benefits are hereby made with immediate effect, empowering following Units of Sindh Police to dispose-of applications / cases of welfare benefits at their end:-

- a. SPU, Sindh
- b. Rapid Response Force (RRF), Sindh
- c. Traffic Licensing & Training, Sindh
- 2. These Welfare Benefits shall be disbursed as per applicable date shown against each:-

- 3. The disbursement of above benefits shall be made as per S.O.P given below:-
 - As per SPBWF Rules-2017, all expenditure should be made through Range / Unit Welfare Committee.
 - b. Applications / Cases of above cited benefits shall be considered /scrutinized by the respective Range Welfare Committees as per criteria laid down in SPBWF Rules-2017 / existing policy. Copy of rules / policy & criteria is annexed.
 - c. All disbursement should be made through cross cheque / online system. No manual payment shall be made in any case.

- d. Copy of sanction order/disbursement of each case should be sent to the office of AIGP Welfare CPO.
- e. Disbursement against marriage grant, retirement grant and immediate relief should be made as per fixed rates. Besides, medical / financial aid should not be exceeded Rs.100,000/-. However, if amount exceeds (in case of chronic disease) then case may be referred to Welfare Branch, CPO.
- f. Details of monthly return with Expenditure should be furnished to AIGP Welfare Sindh.
- g. Internal / External audit of all expenditure shall be conducted on quarterly basis.

Note:-To avoid duplication of claims, it may please be ensured that record of all payments should be maintained with CNICs of applicant / beneficiary with A.G PERSONAL NUMBER OF POLICE PERSONNEL & Such record of payments must be computerized through HRMS System.
